In the past, the U.S. Supreme Court relied upon research on adolescent brain development to bar execution and limit sentences of Life Without Possibility of Parole for crimes committed under age 18. Recently, however, the U.S. Supreme Court shifted the battleground from the federal level to the states in its ruling on Jones v. Mississippi (2021). 
