This symposium considers the plagued history of forced pregnancy and coerced adoption, the inherent misunderstandings of safe haven laws, the role of the family policing system in public relinquishment and separation, the current practice of adoption in the United States, and the ways in which the Supreme Court's understanding of adoption will impact not just reproductive rights, but issues as seemingly tangential as Indian tribal sovereignty.

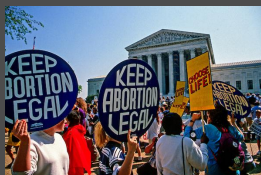

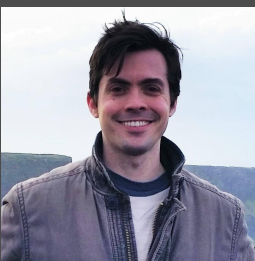

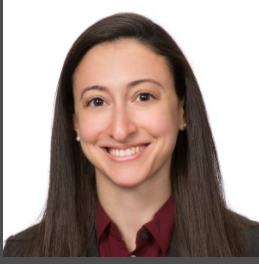
